Short title

1. This regulation may be cited as the *Forestry Amendment Regulation* (*No.* 6) 1997.

- (c) the order in council published in the gazette on 19 December 1959 at page 2 205 reserving and setting apart land in the county of Bulwer, parish of Moraby for timber purposes.
- (2) To avoid any doubt, the reservation of land mentioned in subsection (1)(c) is revoked.
