# Superannuation (State Public Sector) Amendment of Deed (No. 1)

# **Short title**

**1.** This regulation may be cited as the *Superannuation (State Public Sector) Amendment of Deed Regulation (No. 1) 1998.* 

#### Commencement

2. This regulation commences on 1 February 1998.

**3.** This regulation approves the amendments of the *Superannuation* (*State Public Sector*) *Deed 1990* in the schedule.

# 'Crediting of earnings

- '337.(1) The board must credit a member's voluntary preservation account with the amount, decided by the board, that reasonably reflects the after tax earnings derived from the investment of the amount in the account.
  - '(2) In deciding the amount, the board must have regard to—
    - (a) the cost of administering all voluntary preservation accounts; and
    - (b) the charges incurred in the investment of amounts in all voluntary preservation accounts; and
    - (c) the allocation to, or deduction from, a reserve held for smoothing returns from the investment of amounts in all voluntary preservation accounts; and

### SCHEDULE (continued)

(d) if, under an investment policy established under section 111 of the Act, members may choose between 2 or more investment strategies—the investment strategies chosen by the member for the account.'.
