Short title

1. This regulation may be cited as the *Forestry Amendment Regulation (No. 2) 1998*.

Regulation amended

2. This regulation amends the *Forestry Regulation 1987*.

Amendment of s 5 (Interpretation)

3. Section 5—

insert—

‘ “**officer**”, of the corporation, means a forest officer or an employee or agent of the corporation.

“**special access**” means the right to gain access to an area of State forest to conduct a particular activity, if the conduct of the activity would not otherwise be generally permitted.

“**special supervision**” means supervision by an officer of the corporation of the conduct of an activity—

- (a) capable of causing physical damage to a person or property; or
- (b) requiring the maintenance of particular surroundings; or
- (c) capable of disturbing the maintenance of particular surroundings.

Example of conduct requiring the maintenance of particular surroundings—

Remaining silent if, for the appropriate enjoyment of a particular area of State forest, it is necessary for all persons in the area to remain silent.

Example of conduct capable of disturbing the maintenance of particular surroundings—

Talking loudly in an area that is a platypus habitat if, for platypus to continue to be visibly present in the area, it is necessary for all persons in the area to remain silent.’.

‘(a) Camping permit (other than if a commercial activity permit is required)—	
(i) fee for overnight camping for an activity under the permit that is for an educational purpose—each person aged over 4 years	2.00
(ii) fee for overnight camping for an activity under the permit that is for a purpose other than an educational purpose—	
(A) for each person aged over 4 years	3.50
(B) for each party of at least 4 persons camping together if no more than 2 persons in the party are aged over 15 years	14.00
(b) Commercial activity permit for filming or photography (if no structures are erected by the permittee)—	
(i) for an activity involving 1 or 2 persons—	
(A) application fee	nil
(B) fee for a day or part of a day	21.00
(ii) for an activity involving 3 to 5 persons—	
(A) application fee	105.00
(B) fee for a day or part of a day	52.00
(iii) for an activity involving at least 6 persons—	
(A) application fee	210.00
(B) fee for a day or part of a day	105.00
(c) Commercial activity permit for filming or photography (if structures are erected by the permittee)—	
(i) for an activity involving 1 to 5 persons—	
(A) application fee	105.00
(B) fee for a day or part of a day	105.00
(ii) for an activity involving 6 to 25 persons—	
(A) application fee	525.00
(B) fee for a day or part of a day	525.00
(iii) for an activity involving 26 to 50 persons—	
(A) application fee	1 050.00
(B) fee for a day or part of a day	1 050.00
(iv) for an activity involving at least 51 persons—	
(A) application fee	2 100.00
(B) fee for a day or part of a day	2 100.00
(d) Commercial activity permit (other than for filming or	

photography)—

(i) application fee	200.00
(ii) renewal fee for permit on identical terms and if the application for renewal is made before expiry	100.00
(iii) fee for 3 months or less	40.00
(iv) fee for more than 3 months but no more than 12 months	160.00
(v) fee for more than 12 months but not more than 24 months	320.00
(vi) fee for more than 24 months but not more than 36 months	456.00
(vii) fee for each person who is a client of the permittee and is engaging in the activity—	
(A) for 3 hours or less	1.15
(B) for a day, or part of a day if the part is more than 3 hours	2.30
(viii) fee for overnight camping for each person who is a client of the permittee and is engaging in the activity	3.50’.

(2) Schedule 1, paragraph (k)—

omit, insert—

‘(k) Group activity permit if special access or special supervision is provided by the corporation or if an area of State forest is reserved by the corporation for the conduct of the activity under the permit—

(i) application fee	20.00
(ii) fee for a day or part of a day—	
(A) for an activity that is vehicle based—for each vehicle	3.00
(B) for an activity that is not vehicle based—for each person	1.50’.
