Short title

1. This regulation may be cited as the *Transport Legislation Amendment Regulation 1998*.

Postponed commencement of uncommenced provisions—the Act, ss 28 and 29

2.(1) In this section—

"postponed law" means the *Transport Legislation Amendment Act 1997*, sections 28 and 29.¹

(2) The period before automatic commencement, under the *Acts Interpretation Act 1954*, section 15DA(2), of the postponed law is extended to the end of 30 November 1999.²

Postponed commencement of uncommenced provision—the Act, s 63

3.(1) In this section—

"postponed law" means the *Transport Legislation Amendment Act 1997*, section 63.³

(2) The period before automatic commencement, under the *Acts Interpretation Act 1954*, section 15DA(2), of the postponed law is extended to the end of 30 April 1999.⁴

Postponed commencement of uncommenced provision—the Act, s 64

4.(1) In this section—
