#### Short title

**1.** This regulation may be cited as the *Traffic Amendment Regulation* (No. 1) 1999.

#### Regulation amended

- **2.(1)** The schedule amends the *Justices Regulation 1993*.
- (2) The remainder of this regulation amends the *Traffic Regulation 1962*.

#### Amendment of s 50 (Obeying the speed limit)

3.(1) Section 50(2)(a), after 'road'—

insert—

'is'.

**(2)** Section 50(5)—

omit, insert—

- '(5) Despite subsection (2), a person must not drive—
  - (a) an oversize vehicle, that is required under the *Transport Operations (Road Use Management) Regulation 1995* to travel with a pilot or escort vehicle, at a speed over 80 km/h on a road where the speed limit otherwise applying under subsection (2) is more than 80 km/h; or
  - (b) a road train at a speed over 90 km/h on a road where the speed limit otherwise applying under subsection (2) is more than 90 km/h.

Maximum penalty—20 penalty units.'.
