- **6.** Section 25, to the extent it omits section 63 and inserts new section 63(1), (2), (4) and (5).
- 7. Section 32, to the extent it inserts new section 68A.
- **8.** Section 48, to the extent it inserts new section 72ZVA.
- 9. Section 69(3), to the extent it omits section 92(2) to (7) and inserts new section 92(2), (3), (5) and (6).
- **10.** Section 74, to the extent it inserts new section 96A.
- 11. Section 100(2), to the extent it inserts new section 163(3).
- **12.** Section 122, to the extent it inserts new part 11, division 2 heading.

- **13.** Section 122, to the extent it inserts new section 223 (but only to the extent new section 223 relates to the definitions "existing control system", "existing operator" and "submission period").
- **14.** Section 122, to the extent it inserts new section 225.
- **15.** Parts 3 and 4, part 5 (other than section 132) and parts 6 and 7.
