1 Short title

This regulation may be cited as the *Health* (*Drugs and Poisons*) Amendment Regulation (No. 1) 2002.

2 Commencement

This regulation commences on 27 September 2002.

(3) Also, subsection (1) does not apply to a person who manufactures, obtains, possesses, sells or uses cannabis sativa under—

- (a) a licence issued under the Drugs Misuse Act 1986, section 49; or
- (b) a regulation under section 48(1) of that Act.¹'.

6 Amendment of s 292 (Advertising of poisons)

'(5) Subsection (4) does not apply to a person who refers to cannabis sativa in an advertisement in connection with an activity authorised under the *Drugs Misuse Act 1986*, section 47 or 48(1).^{2'}.
