1 Short title

This regulation may be cited as the *Nature Conservation* (*Protected Areas*) Amendment Regulation (No. 1) 2005.

2 Regulation amended

This regulation amends the *Nature Conservation (Protected Areas) Regulation 1994.*

'416 Description

'The part of lot 46 on EV811519 situated in the County of Evora, containing an area of about 667ha, shown on plan PA183.

'417 Significant cultural and natural resources and values

- (a) the following not of concern regional ecosystems that have a low representation in the protected area estate—
 - (i) *Acacia shirleyi* woodland or *A. catenulata* low woodland at margins of plateaus, described as regional ecosystem 10.7.3;
 - (ii) *Eucalyptus thozetiana* open woodland on scarps and on pediments below scarps, described as regional ecosystem 10.7.5; and
- (b) catchment protection for Nugget Creek.

'420 Significant cultural and natural resources and values

 - (ii) *Eucalyptus cambageana* woodland to open forest with *Acacia harpophylla* or *A. argyrodendron* on Cainozoic clay plains, described as regional ecosystem 11.4.8, that has a low representation in the protected area estate; and
- (b) regional ecosystems that are poorly represented in the protected area estate; and
- (c) a high diversity of species and regional ecosystems, as the boundary between the Brigalow Belt and Desert Uplands bioregions runs through the nature refuge; and

- (b) known habitat for the vulnerable koala (*Phascolarctos cinereus*); and
- (c) suitable habitat for rare or threatened species, including the following—
 - (i) the endangered plant Cossinia australiana;
 - (ii) the vulnerable small leaved denhamia (*Denhamia parvifolia*);
 - (iii) the rare black-chinned honeyeater (*Melithreptus* gularis) and grey goshawk (*Accipiter* novaehollandiae).

'The part of lot 7 on RP206440 situated in the County of Bentinck, containing an area of about 40.4ha, shown on plan PA181.

'429 Significant cultural and natural resources and values

'The nature refuge supports—

- (a) shrubland on igneous rocks, described as the of concern regional ecosystem 13.12.6; and
- (b) suitable habitat for the following rare or threatened species—
 - (i) the endangered plant Boronia granitica;
 - (ii) the rare turquoise parrot (Neophema pulchella);
 - (iii) the rare plant Thelionema grande; and
- (c) cultural and natural resources of the adjacent Tumbledown Nature Refuge.

'432 Significant cultural and natural resources and values

- (a) remnant vegetation in good condition and equivalent to the following not of concern regional ecosystems that have a low representation in the protected area estate—
 - (i) *Eucalyptus grandis* tall open forest on alluvial plains, described as regional ecosystem 12.3.2;

- (ii) *Eucalyptus pilularis* tall open forest on sedimentary rocks, described as regional ecosystem 12.9-10.14;
- (iii) open forest complex often with *Eucalyptus* acmenoides, E. major, E. siderophloia ± Corymbia citriodora on sedimentary rocks, described as regional ecosystem 12.9-10.17; and
- (b) a high level of floristic diversity with more than 330 flora species recorded; and

'435 Significant cultural and natural resources and values

'The nature refuge supports-

- Notophyll rainforest/microphyll rainforest often with (a) Argyrodendron polyandrum and Paraserianthes toona, ± Araucaria cunninghamii, on low to medium ranges on Mesozoic to Proterozoic igneous rocks, described as the not of concern regional ecosystem 8.12.3; and
- (b) suitable habitat for rare or threatened species, including-
 - (i) vulnerable plants Actephila sp. (Koumala I.G. Champion 870), Graptophyllum ilicifolium and *Neisosperma kilneri*; and
 - (ii) rare plants Actephila sessilifolia, Atalaya rigida, dietrichiana, ironwood Bonamia giant subargentea). *Macropteranthes* (Choricarpia fitzalanii and Rhodamnia pauciovulata; and

- (a) a vegetation community equivalent to the not of concern regional ecosystem 8.12.9, an ecosystem that has a low representation in the protected area estate; and
- (b) suitable habitat for rare or threatened species, including—
 - (i) the vulnerable glossy black-cockatoo (*Calyptorhynchus lathami*), powerful owl (*Ninox strenua*) and rufous owl (*Ninox rufa queenslandica*); and
 - (ii) the rare plant *Plectranthus graniticola*.

'The part of lot 48 on crown plan CSH140 situated in the County of Cavendish, containing an area of about 60.5ha, shown on plan PA205.

'441 Significant cultural and natural resources and values

- (a) a number of not of concern regional ecosystems that have a low representation in the protected area estate, including the following—
 - (i) *Eucalyptus grandis* tall open forest on alluvial plains, described as regional ecosystem 12.3.2;
 - (ii) Eucalyptus tereticornis, Callistemon viminalis, Casuarina cunninghamiana fringing forest, described as regional ecosystem 12.3.7;
 - (iii) open forest complex with *Corymbia citriodora* on subcoastal remnant Tertiary surfaces, usually with deep red soils, described as regional ecosystem 12.5.1;

'444 Significant cultural and natural resources and values

'The nature refuge supports—

- (a) a vegetation community equivalent to the following of concern regional ecosystems—
 - (i) simple notophyll vine forest usually with abundant *Archontophoenix cunninghamiana (gully vine forest)* on Mesozoic to Proterozoic igneous rocks, described as regional ecosystem 12.12.1, that has a low representation in the protected area estate;
 - (ii) shrubby woodland with *Eucalyptus dura* on rocky peaks on Mesozoic to Proterozoic igneous rocks, described as regional ecosystem 12.12.9; and
- (b) 3 large specimens of the endangered *Cycas megacarpa*; and
- (c) vegetation that is part of a bioregional wildlife corridor.

'447 Significant cultural and natural resources and values

'The nature refuge supports—

- (a) the following regional ecosystems that have a low representation in the protected area estate—
 - (i) *Melaleuca irbyana* low open forest on sedimentary rocks, described as the endangered regional ecosystem 12.9-10.11;
 - (ii) *Eucalyptus crebra* woodland on sedimentary rocks, described as the of concern regional ecosystem 12.9-10.7; and
- (b) known habitat for rare or threatened species, including—
 - (i) the rare plant bush house paperbark (*melaleuca irbyana*); and
 - (ii) the vulnerable koala (phascolarctus cinereus).

'449 Description

'The part of lot 37 on crown plan HR1352 situated in the County of Herbert, containing an area of about 813ha, shown on plan PA118.

'450 Significant cultural and natural resources and values

- (a) the following of concern regional ecosystems—
 - (i) *Eucalyptus tereticornis* and/or *Eucalyptus* spp. tall woodland on alluvial plains, described as regional ecosystem 11.3.4, that has a low representation in the protected area estate;
 - (ii) *Eucalyptus exserta, E. moluccana, E. crebra, Corymbia citriodora* woodland on igneous rocks, described as regional ecosystem 11.12.19; and
- (b) conservation of the following not of concern regional ecosystems that have a low representation in the protected area estate—
 - (i) *Eucalyptus tereticornis* or *E. camaldulensis* woodland fringing drainage lines, described as regional ecosystem 11.3.25;

'The part of lot 364 on crown plan AM840884 and the part of lot 3 on crown plan AM805052 situated in the County of Amaroo, containing an area of about 215454ha, shown on plan PA193.

'453 Significant cultural and natural resources and values

- (a) a wide range of arid zone regional ecosystems; and
- (b) suitable habitat for a variety of animals, including many seasonal and migratory waterbirds; and
- (c) a number of artesian springs with significant natural and cultural values; and
- (d) part of the Mulligan River–Wheeler Creek Junction wetland, an area listed as a wetland of importance in the Queensland chapter of 'A directory of important wetlands in Australia' as published by the Australian Nature Conservation Agency, 2001, Canberra;¹ and

'The part of lot 9 on RP738319 and the part of lot 8 on RP742153 situated in the County of Carlisle, containing an area of about 1.41ha, shown on plan PA198.

456 Significant cultural and natural resources and values

- (a) the vegetation community *Melaleuca* spp. woodland in parallel dune swales (wetlands), equivalent to the of concern regional ecosystem 8.2.11, that has a low representation in the protected area estate; and
- (b) the vegetation community Microphyll vine forest on coastal dunes, equivalent to the of concern regional ecosystem 8.2.2, that has a low representation in the protected area estate; and
- (c) protection of wetland habitat used by migratory birds and significant species under international agreements relating to the migration of birds between Australia and Japan or Australia and China;² and
- (d) known habitat for the rare radjah shelduck (*Tadorna radjah*).

'459 Significant cultural and natural resources and values

- (a) vegetation that adjoins Wooroonooran National Park and the Wet Tropics World Heritage Area; and
- (b) known habitat for a number of vulnerable or rare species, including the rare Herbert River ringtail possum (*Pseudochirulus herbertensis*), green ringtail possum (*Pseudochirops archeri*) and Lumholtz's tree-kangaroo (*Dendrolagus lumholtzi*); and
