# 'Part 162 Cloudland Nature Refuge

'484 Name

'Cloudland Nature Refuge.

## '485 Description

'Lot 29 on crown plan NR426 situated in the County of Nares, containing an area of about 80ha, shown on plan PA247.

## '486 Significant cultural and natural resources and values

- (a) complex notophyll vine forest on cloudy wet basalt uplands and highlands, described as the endangered regional ecosystem 7.8.4, that has a low representation in the protected area estate; and
- (b) known habitat for rare and threatened species, including—
  - (i) the endangered southern cassowary (southern population) (*Casuarius casuarius*); and
  - (ii) the rare Lumholtz's tree-kangaroo (Dendrolagus lumholtzi), lemuroid ringtail possum (Hemibelideus lemuroides), green ringtail possum (Pseudochirops archeri) and Herbert River ringtail possum (Pseudochirulus herbertensis); and

- (b) the cultural and natural values of the adjacent Herberton Range Forest Reserve and the nearby Barne's Pikle, Cloudland, Pember's Scrub, Sweetwater Valley and Wundajilla Forest Nature Refuges and Mount Hypipamee National Park.

  - (i) the vulnerable rufous owl (southern subspecies) (*Ninox rufa queenslandica*); and
  - (ii) the rare grey goshawk (Accipiter novaehollandiae), radjah shelduck (Tadorna radjah) and the slender or narrow-leaved parsonsia (Parsonsia lenticellata).

  - (i) *Melaleuca viridiflora* woodland often with emergent eucalypts and grassy/herbaceous ground layer, on seasonally inundated alluvial plains with impeded drainage, described as the endangered regional ecosystem 8.3.2;
  - (ii) semi-deciduous notophyll/mesophyll vine forest fringing watercourses on alluvial plains, described as the of concern regional ecosystem 8.3.1; and
- (b) suitable habitat for rare and threatened species including—

  - (ii) tall shrubby open forest often with *Eucalyptus resinifera*, *E. grandis*, *Corymbia intermedia* on sedimentary rocks, described as the of concern regional ecosystem 12.9-10.1;
  - (iii) open forest complex often with *Eucalyptus* acmenoides, *E. major*, *E. siderophloia* ± Corymbia citriodora on sedimentary rocks, described as the not of concern regional ecosystem 12.9-10.17; and
- (b) known habitat for rare or threatened species including—
  - (i) the vulnerable tusked frog (*Adelotus brevis*), koala (*Phascolarctos cinereus*) and penda (*Xanthostemon oppositifolius*); and

#### '6 Plants

'A plant indigenous to Australia, other than an extinct in the wild, endangered, vulnerable, rare or near threatened plant, is a least concern plant.

# **'Part 3 Declared management intent**

#### '7 Significance

'Least concern wildlife are a feature of Queensland's biodiversity and are often vital components of the ecosystem they live in, representing—

- (a) a source of genetic information integral to an understanding of the evolution of the Australian biota; and
- (b) a genetic resource of potential benefit to society.

#### '8 Proposed management intent

- (1) The proposed management intent for least concern wildlife is as follows—
  - (a) to monitor and review the conservation status of the wildlife;
  - (b) to the extent practicable, to prepare and put into effect conservation plans or other instruments for least concern wildlife—
    - (i) of commercial, recreational, traditional and potential conservation interest; or
    - (ii) the chief executive considers to be potentially vulnerable;

- (c) to encourage genuine research and inventory programs—
  - (i) likely to contribute to an understanding of the wildlife or Australia's biota; or
  - (ii) likely to be of benefit to society;
- (d) to incorporate into educational material and programs information about the wildlife's contribution to Queensland's and Australia's biodiversity.
- (2) In addition, the proposed management intent for-
  - (a) the koala (*Phascolarctos cinereus*), echidna (*Tachyglossus aculeatus*) and platypus (*Ornithorhynchus anatinus*); and
  - (b) least concern birds to which the following apply—
    - 'Agreement between the Government of Australia and the Government of Japan for the Protection of Migratory Birds and Birds in Danger of Extinction and their Environment', signed at Tokyo on 6 February 1974
    - 'Agreement between the Government of Australia and the Government of the People's Republic of China for the Protection of Migratory Birds and Birds in Danger of Extinction and their Environment', signed at Canberra on 20 October 1986
    - 'Convention on the Conservation of Migratory Species of Wild Animals', signed at Bonn on 23 June 1979;

includes ensuring governments have regard to the special cultural significance of the wildlife and the management requirements needed to conserve existing populations of the wildlife.

## **'9** Principles for the taking and use of least concern wildlife

'The taking and use of least concern wildlife under a licence, permit or other authority under the Act may be permitted only

if it is consistent with the management principles for the wildlife.1'.
