This regulation may be cited as the *Nature Conservation (Protected Areas) Amendment Regulation (No. 1) 2006*.

2 Regulation amended

This regulation amends the *Nature Conservation (Protected Areas) Regulation 1994*.

'549 Significant cultural and natural resources and values

'The nature refuge supports—

- (a) complex notophyll to mesophyll vine forest of high rainfall, cloudy uplands on basalt, described as the not of concern regional ecosystem 7.8.2; and
- (b) known habitat for the endangered southern cassowary (southern population) (*Casuarius casuarius*); and
- (c) suitable habitat for the rare Lumholtz's tree-kangaroo (*Dendrolagus lumholtzi*); and
- (d) the cultural and natural values of a significant part of the Topaz Regional Landscape Linkage between the Wooroonaoran National Park sections of the Wet Tropics World Heritage Area.

 - (i) *Eucalyptus crebra*, *Corymbia* spp., with *E. moluccana* on lower slopes of Cainozoic sand plains/remnant surfaces, described as regional ecosystem 11.5.2;
 - (ii) *Acacia* spp. woodland on lateritic duricrust, Scarp retreat zone, described as regional ecosystem 11.7.2; and
- (b) the cultural and natural values of the adjoining Eugene State Forest.

'555 Significant cultural and natural resources and values

'The nature refuge supports—

- (a) complex notophyll (feather palm) vine forest often with *Acmena resa* and *Syzygium wesa*, of wet uplands on Mesozoic to Proterozoic igneous rocks, described as the not of concern regional ecosystem 8.12.1; and
- (b) notophyll to complex notophyll vine forest often with *Argyrodendron actinophyllum* subsp. *diversifolium* ± *A. polyandrum*, on drier uplands and coastal ranges on Mesozoic to Proterozoic igneous rocks, described as the

not of concern regional ecosystem 8.12.2, that has a low representation in the protected area estate; and

- (c) suitable habitat for rare and threatened species including—
 - (i) the endangered Eungella torrent frog (*Taudactylus eungellensis*) and northern gastric brooding frog (*Rheobatrachus vitellinus*); and
 - (ii) the vulnerable plant *Ozothamnus eriocephalus*; and

- (a) *Eucalyptus drepanophylla* ± *E. platyphylla* ± *Corymbia clarksoniana* woodland on low to medium hills, on Mesozoic to Proterozoic igneous rocks, described as the not of concern regional ecosystem 8.12.6, that has a low representation in the protected area estate; and
- (b) suitable habitat for rare and threatened species including—
 - (i) the vulnerable rufous owl (southern subspecies) (*Ninox rufa queenslandica*) and coastal sheathtail bat (*Taphozous australis*); and
 - (ii) the rare grey goshawk (*Accipiter novaehollandiae*); and
- (c) the cultural and natural values of the nearby Pioneer Peaks National Park; and
- (d) protection of significant regrowth providing viable habitat and adjoining remnant vegetation that links 2 sections of Pioneer Peaks National Park.

- (a) the following regional ecosystems that have a low representation in the protected area estate—
 - (i) *Eucalyptus saligna* or *E. grandis* tall open forest on Cainozoic igneous rocks, described as the of concern regional ecosystem 12.8.8;
 - (ii) complex notophyll vine forest on Cainozoic igneous rocks at altitude <600m, described as the not of concern regional ecosystem 12.8.3;
 - (iii) *Eucalyptus siderophloia*, *E. propinqua*, *E. acmenoides* open forest on near coastal hills on Mesozoic to Proterozoic igneous rocks, described as the not of concern regional ecosystem 12.12.15; and
- (b) known habitat for rare and threatened species including—
 - (i) the vulnerable Richmond birdwing butterfly (*Ornithoptera richmondia*); and
 - (ii) the rare *Pararistolochia praevenosa*; and

 - (i) Araucarian microphyll to notophyll vine forest on sedimentary rocks, described as the of concern regional ecosystem 12.9-10.16;
 - (ii) *Eucalyptus pilularis* tall open forest on sedimentary rocks, described as the not of concern regional ecosystem 12.9-10.14;
 - (iii) open forest complex often with *Eucalyptus acmenoides*, *E. major*, *E. siderophloia* ± *Corymbia citriodora* on sedimentary rocks, described as the not of concern regional ecosystem 12.9-10.17; and
- (b) part of a state significant bioregional wildlife corridor; and
- (c) known habitat for rare and threatened species, including—
 - (i) the vulnerable glossy black-cockatoo (*Calyptorhynchus lathami*), powerful owl (*Ninox strenua*), koala (*Phascolarctos cinereus*), and tusked frog (*Adelotus brevis*); and

'567 Significant cultural and natural resources and values

(a) the following regional ecosystems—

- (i) notophyll mossy evergreen vine forest on mountain slopes and summits subject to regular mist cover, on Mesozoic to Proterozoic igneous rocks, described as the of concern regional ecosystem 8.12.17;
- (ii) notophyll rainforest/microphyll rainforest often with *Argyrodendron polyandrum* and *Paraserianthes toona*, ± *Araucaria cunninghamii*, on low to medium ranges on Mesozoic to Proterozoic igneous rocks, described as the not of concern regional ecosystem 8.12.3;
- (iii) *Corymbia intermedia*, *E. portuensis* ± *Lophostemon* spp. ± *Syncarpia glomulifera* ± *Banksia integrifolia*, open forest on Mesozoic to Proterozoic igneous rocks, described as the not of concern regional ecosystem 8.12.5;

- (b) the cultural and natural values of the adjoining Wet Tropics World Heritage Area; and
- (c) known habitat for the endangered southern cassowary (southern population) (*Casuarius casuarius*).

 - (ii) the vulnerable crimson finch (*Neochmia phaeton*); and
- (b) the cultural and natural values of the adjoining Lakefield and Cape Melville National Parks; and
- (c) significant indigenous and European cultural heritage values in the areas of Barney's Lake, Bathurst Head, Jacks Lakes, and the Jack, Normanby and Kennedy Rivers.

- (b) simple notophyll vine forest of moist to very wet metamorphic uplands and highlands, described as the not of concern regional ecosystem 7.11.12; and
- (c) known habitat for the endangered southern cassowary (southern population) (*Casuarius casuarius*); and
- (d) the cultural and natural values of the adjoining Wooroonaoran National Park and the Wet Tropics World Heritage Area, and the adjacent Rayner Nature Refuge.

- (a) simple to complex mesophyll to notophyll vine forest on moderately to poorly drained metamorphics (excluding amphibolites) of moderate fertility of the moist and wet lowlands, foothills and uplands, described as the not of concern regional ecosystem 7.11.1; and
- (b) known habitat for the vulnerable rufous owl (southern subspecies) (*Ninox rufa queenslandica*) and the rare Litoria genimaculata and double-eyed fig parrot (Marshall's) (*Cyclopsitta diophthalma marshalli*); and
- (c) suitable habitat for the endangered southern cassowary (southern population) (*Casuarius casuarius*), and endangered frogs *Litoria lorica*, *Litoria rheocola* and *Nyctimystes dayi*; and

 - (ii) *Eucalyptus fibrosa* subsp. *fibrosa* open forest on sedimentary rocks, described as the not of concern regional ecosystem 12.9-10.19; and
- (b) suitable habitat for the rare black-necked stork (*Ephippiorhynchus asiaticus*), black-chinned honeyeater (*Melithreptus gularis*) and square-tailed kite (*Lophoictinia isura*); and

- (a) *Eucalyptus saligna* or *E. grandis*, *E. microcorys*, *E. acmenoides*, *Lophostemon confertus* tall open forest on metamorphics ± interbedded volcanics, described as the not of concern regional ecosystem 12.11.2; and
- (b) suitable habitat for the vulnerable *Cyperus semifertilis*; and
- (c) the cultural and natural values of the adjoining Austinville Forest Reserves 1 and 2; and
- (d) vegetation forming part of a bioregional wildlife corridor linking to Springbrook National Park.

 - (i) simple to complex mesophyll to notophyll vine forest on moderate to poorly drained alluvial plains of moderate fertility, described as the of concern regional ecosystem 7.3.10;
 - (ii) *Corymbia intermedia* and/or *C. tessellaris* ± *Eucalyptus tereticornis* medium to tall open forest to woodland (or vine forest with these species as emergents), on coastal metamorphic headlands and near-coastal foothills, described as the of concern regional ecosystem 7.11.18;
 - (iii) simple to complex mesophyll to notophyll vine forest on moderately to poorly drained metamorphics (excluding amphibolites) of moderate fertility of the moist and wet lowlands, foothills and uplands, described as the not of concern regional ecosystem 7.11.1; and
- (b) known habitat for the rare *Polyosma rigidiuscula*; and
- (c) suitable habitat for rare and threatened species including—

- (b) known habitat for rare and threatened species, including—
 - (i) the vulnerable spotted-tailed quoll (*Dasyurus maculatus maculatus*); and
 - (ii) the rare superb lyrebird (*Menura novaehollandiae*); and

- (c) known habitat for the endangered star finch (eastern subspecies) (*Neochmia ruficauda ruficauda*); and

- (d) significant indigenous cultural heritage values and areas of indigenous cultural heritage interest; and
- (e) the cultural and natural values of the adjacent Lakefield National Park.

'9 Interim management intent and use

- ‘(1) The coordinated conservation area consists of the area that is the subject of the conservation agreement for the area.
- ‘(2) The coordinated conservation area will be managed to—
