Part 1 Preliminary

1 Short title

This regulation may be cited as the *Nature Conservation Legislation Amendment Regulation (No. 2) 2006*.

2 Purpose of regulation

- (1) The purpose of this regulation is to revoke the dedication of the forest reserves mentioned in section 4 (each a *revoked forest reserve area*) to allow the forest reserves to become protected areas.
- (2) Each revoked forest reserve area is dedicated as a protected area, or part of a protected area, under part 3.
