### **1        Short title**

This zoning plan may be cited as the *Marine Parks (Zoning Plans) Amendment Zoning Plan (No. 1) 2006*.

### **2        Commencement**

This zoning plan commences on 31 August 2006.

## **Part 2                      Amendment of Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004**

### **3        Zoning plan amended in pt 2**

This part amends the *Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004*.

### **4        Replacement of s 1 (Short title)**

Section 1—

*omit, insert*—

#### **'1        Short title**

- ‘(1) This zoning plan may be cited as the *Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004*.
- ‘(2) This zoning plan may also be cited as the Great Barrier Reef Coast Marine Park Zoning Plan.’.

### **5        Amendment of s 3 (Interpretation of terms generally)**

- (1) Section 3(3)(d), ‘the regulation’—

*omit, insert—*

‘the Regulation, part 3’.

- (2) Section 3(3)(e), before ‘this plan’—

*insert—*

‘the Regulation or’.

- (3) Section 3(3)(f), ‘this plan’—

*omit, insert—*

‘the Regulation’.

## **6 Amendment of s 4 (Applying Commonwealth purposes to marine park)**

- (1) Section 4(2)(e), ‘the regulation’—

*omit, insert—*

‘the Regulation, part 3’.

- (2) Section 4(2)(g), ‘objective stated in this plan’—

*omit, insert—*

‘object to be achieved, under this plan,’.

- (3) Section 4(2)(h), before ‘this plan’—

*insert—*

‘the Regulation or’.

- (4) Section 4(2)(j)(ii), from ‘by the Minister’—

*omit, insert—*

‘under part 3, division 2 of the Act.<sup>1</sup>’.

**'6A References to particular bodies of water**

'A reference to a bay, creek, harbour, river or similar body of water in schedule 2, 3, 4, 5, 6 or 7 is a reference to all the tidal waters and tidal land in the bay, creek, harbour, river or body of water that is within the marine park, and includes the tidal land and tidal waters of a tributary of the bay, creek, harbour, river or body of water.'

'The objects to be achieved for each zone mentioned in section 16(1) are stated in the Regulation, schedule 1.'

**10 Amendment of s 25 (Entry or use without permission)**

Section 25(b)(vii), 'in an accredited harvest fishery'—

'under an accredited harvest fishery and'.

Section 26(2), definition *relevant purpose*, paragraph (a)(i), 'in a'—

**12 Amendment of s 53 (Application for permission must include particular information)**

Section 81(3), definition *closed period*, paragraph (b)—

- ‘(b) for another seasonal closure area—the period of closure decided by the chief executive for the area and—
  - (i) stated in a public notice; and
  - (ii) published on the department’s website on the Internet.’.

**14 Omission of s 89 (Entry or use for undertaking functions under the Act)**

Section 89—

**15 Amendment of s 90 (Entry or use without permission after notification)**

- (1) Section 90(1), from ‘(g), if the person’—

*omit, insert*—

‘(g).’.

- (2) Section 90(2)—

*renumber* as section 90(4).

- (3) Section 90—

*insert*—

- ‘(2) However, a person intending to enter or use an area within the marine park for a purpose mentioned in subsection (1) must

give the chief executive a notice stating the person intends to enter or use the area for the purpose.

- ‘(3) The chief executive may, upon receiving the notice, impose conditions on the entry or use.

*Note—*

See section 45 of the Act and section 112 of the Regulation for offences relating to a person entering or using a marine park for a purpose for which a notice must be given to the chief executive.’.

Section 113, ‘the regulation’—

*omit, insert—*

‘the Regulation’.

- ‘(2) This zoning plan may also be cited as the Moreton Bay Marine Park Zoning Plan.’.

**24 Omission of s 9 (Compliance with plan)**

Section 9—

*omit.*

**25 Amendment of ss 28 and 32**

Sections 28 and 32, from ‘Despite’ to ‘person’—

*omit, insert*—

‘A person’.

**26 Amendment of s 62 (Access in special circumstances)**

Section 62(2) to (4)—

*omit, insert*—

- ‘(2) However, a person intending to enter or use the marine park for a purpose mentioned in subsection (1) must give the chief

executive a notice stating the person intends to enter or use the marine park for the purpose.

- (3) The chief executive may, upon receiving the notice, impose conditions on the entry or use.

*Note—*

See section 45 of the Act and section 112 of the Regulation for offences relating to a person entering or using a marine park for a purpose for which a notice must be given to the chief executive.'

## 27 Amendment of sch 4 (Dictionary)

**'the Regulation'** means the *Marine Parks Regulation 2006*.

- (2) Schedule 4, definition *waste*, from 'include'—

'include offal of fish or stormwater discharge.'
