This regulation may be cited as the *Health (Drugs and Poisons) Amendment Regulation (No. 1) 2008*.

2 Commencement

This regulation commences on 15 March 2008.

Section 131(2)(c)—

omit, insert—

- ‘(c) a price list that complies with the document called ‘Price Information Code of Practice’, published by the Therapeutic Goods Administration, as in force from time to time.
