1 Short title

This regulation may be cited as the *Family Responsibilities Commission Regulation 2008*.

2 Commencement

This regulation commences on 1 July 2008.

3 Entity prescribed for Act, s 44(7), definition *social housing*

For section 44(7) of the Act, definition *social housing*, paragraph (b), Bamanga Bubu Ngadimunku Inc. ABN 26 904 810 679 is prescribed.

4 Area prescribed for Act, s 94(3), definition *welfare reform community area*

For section 94(3) of the Act, definition *welfare reform community area*, paragraph (e), the area of lot 2 on RP706266 and lot 93 on SR284 is prescribed.

5 Area prescribed for Act, schedule, definition *Coen area*

For the schedule of the Act, definition *Coen area*, paragraph (b), each area described in schedule 1 is prescribed.

6 Area prescribed for Act, schedule, definition *Hope Vale area*

For the schedule of the Act, definition *Hope Vale area*, paragraph (b), each area described in schedule 2 is prescribed.
