Part 1 Preliminary

1 Short title

This regulation may be cited as the *Transport and Other Legislation Amendment Regulation (No. 1) 2008*.

2 Commencement

- (1) This regulation, other than section 17(2), commences on 1 September 2008.
- (2) Section 17(2) commences on 1 March 2009.
