## **Part 1                      Preliminary**

### **1            Short title**

This regulation may be cited as the *Forestry and Nature Conservation Legislation Amendment Regulation (No. 4) 2008*.

### **2            Main purpose of regulation**

- (1) The main purpose of this regulation is to revoke the dedication of the whole of the forest reserves mentioned in section 6(1) to allow the forest reserve (each a *revoked forest reserve area*) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as a protected area under part 4.
