1 Short title

This regulation may be cited as the *Land Protection (Pest and Stock Route Management) Amendment Regulation (No. 1) 2009*.

2 Regulation amended

This regulation amends the *Land Protection (Pest and Stock Route Management) Regulation 2003*.

3 Amendment of sch 1 (Mammals, reptiles and amphibians that are not class 1 pests)

- (1) Schedule 1, item 3, entries for chital (axis) deer (*Axis axis*), fallow deer (*Dama dama*), hog deer (*Axis porcinus*), red deer (*Cervus elaphus*), rusa deer (*Cervus timorensis*), sambar deer (*Cervus unicolor*), wapiti deer (*Cervus canadensis*) and white-tail deer (*odocoileus virginianus*)—
omit.
- (2) Schedule 1, item 3—
insert—
 - chital (axis) deer (*Axis axis*), other than a feral chital (axis) deer
 - fallow deer (*Dama dama*), other than a feral fallow deer
 - red deer (*Cervus elaphus*), other than a feral red deer
 - rusa deer (*Cervus timorensis*), other than a feral rusa deer’.

4 Amendment of sch 2 (Class 1 pest plants, and class 2 and 3 pests)

- (1) Schedule 2, part 2, division 1, item 2—
insert—
 - feral chital (axis) deer (*Axis axis*)
 - feral rusa deer (*Cervus timorensis*)’.

- (2) Schedule 2, part 3, item 4—
renumber as item 5.
 - (3) Schedule 2, part 3, before item 5 as renumbered—
insert—

'Division 1 Animals'

- ‘4 The following animals—
 - feral fallow deer (*Dama dama*)
 - feral red deer (*Cervus elaphus*)

'Division 2 Plants'.

5 Amendment of sch 3 (Purposes and pests for declared pest permits)

- Schedule 3, part 6, item 8—
insert—
- ‘• feral chital (axis) deer (*Axis axis*)
 - feral fallow deer (*Dama dama*)
 - feral red deer (*Cervus elaphus*)
 - feral rusa deer (*Cervus timorensis*)’.

6 Amendment of sch 6 (Dictionary)

- Schedule 6—
insert—
- ‘*feral*, in relation to a deer, means a deer that—
- (a) is living in a wild state; and
 - (b) is not being farmed or kept for any other purpose within a deer-proof enclosure, cage or other structure.’.
