1 Short title

This regulation may be cited as the *Drugs Misuse Amendment Regulation (No. 1) 2009*.

2 Regulation amended

This regulation amends the *Drugs Misuse Regulation 1987*.

‘is’.

(2) Section 4(b), from ‘officer’, including editor’s note—

omit, insert—

‘inspector appointed under the *Health Act 1937*, section 137.’.

5 Amendment of s 6 (Documents and proof of identity required for supply of a controlled substance or controlled thing—Act, s 43D(1)(a))

Section 6(3), ‘drivers’—

omit, insert—

‘driver’.

6 Amendment of schs 1 and 2

Schedules 1 and 2, heading, after ‘sections 4’—

insert—

‘, definition *dangerous drug*’.

7 Amendment of sch 3 (Specified quantities for particular dangerous drugs)

Schedule 3, first column, ‘Cannabis sativa’—

omit, insert—

‘Cannabis’.

8 Amendment of schs 4 and 5

Schedules 4 and 5, heading, after ‘sections’—

insert—

‘4A,’.

9 Amendment of sch 6 (Controlled substances)

Schedule 6, heading, after ‘sections 4’—

insert—

‘, definition *controlled substance*’.

10 Amendment of sch 7 (Conditions for particular persons authorised under part 4)

Schedule 7, section 1(c), ‘must’—

omit.

11 Amendment of sch 8B (Things specified for ss 9A, 9B and 9C of Act)
