Part 1 Preliminary

1 Short title

This regulation may be cited as the *Forestry and Nature Conservation Legislation Amendment Regulation (No. 3) 2009*.

2 Main purpose of regulation

- (1) The main purpose of this regulation is to revoke the dedication of—
 - (a) the whole of the forest reserves mentioned in section 6(1) to allow each forest reserve (a **revoked forest reserve area**) to become a protected area; and
 - (b) the parts of the forest reserves mentioned in section 6(3) to (7) to allow each part (also a **revoked forest reserve area**) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as a protected area under part 4.
