- A contractual provision that deems a direction under the QBSA Act, section 72 given to a construction manager or other building contractor to be a direction given to someone else.
- A contractual provision that requires a building owner to indemnify a construction manager or other building contractor against all liabilities and costs that may arise if a direction under the QBSA Act, section 72 is given to a construction manager or other building contractor.'
