## Part 1 Preliminary

### 1 Short title

This regulation may be cited as the *Forestry and Nature Conservation Legislation Amendment Regulation (No. 6) 2009*.

### 2 Main purpose of parts 2 to 5 of regulation

- (1) The main purpose of parts 2 to 5 of this regulation is to revoke the dedication of the whole of the forest reserves mentioned in section 8(1) to allow each forest reserve (a *revoked forest reserve area*) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as a protected area or part of a protected area under part 5.
