## Part 1 Preliminary

### 1 Short title

This regulation may be cited as the *Forestry and Nature Conservation Legislation Amendment Regulation (No. 2) 2010*.

### 2 Main purpose of regulation

- (1) The main purpose of this regulation is to revoke the dedication of—
  - (a) the whole of the forest reserves mentioned in section 6(1) to allow the forest reserves (each a **revoked forest reserve area**) to become a protected area; and
  - (b) parts of the forest reserves mentioned in section 6(3) to (8) to allow the parts (each also a **revoked forest reserve area**) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as a protected area under part 4.
