1 Short title

This regulation may be cited as the *State Development and Public Works Organisation (State Development Areas) Amendment Regulation (No. 1) 2011.*

2 Regulation amended

This regulation amends the *State Development and Public Works Organisation (State Development Areas) Regulation* 2009.

'Coordinator-General'.

- (3) Section 6(1)—

insert—

- '(da) advising prospective developers about development applications for a material change of use in relation to the GSDA;'.
- (4) Section 6(1)—

insert—

- '(ha) liaising with, including organising meetings between, representatives of industry and members of the community in relation to the GSDA;'.
- (5) Section 6(1)(j), 'GSDA, including providing infrastructure'—

- (6) Section 6(1)(j), examples omit.

 - (b) spend amounts on improvements to, or for maintenance of, property it owns;'.
- (3) Section 7(c), (d), (g) and (h) *omit*.
- (4) Section 7(e), 'open'—*omit, insert*—'operate'.
- (5) Section 7(e) to (j) *renumber* as section 7(c) to (f).
