Part 1 Preliminary

1 Short title

This regulation may be cited as the Forestry and Nature Conservation Legislation Amendment Regulation (No. 4) 2011.

2 Main purpose of regulation

- (1) The main purpose of this regulation is to revoke the dedication of parts of the forest reserves mentioned in section 6(1) to allow each part of the forest reserve (a *revoked forest reserve area*) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as part of a protected area under part 4.
