'19 Certain former Queensland Manufactured Water Authority employees not eligible for membership

- This section applies to an employee of Queensland Manufactured Water Authority who became an employee of Queensland Bulk Water Supply Authority on the transfer day under the South East Queensland Water (Restructuring) Regulation 2011.
- '(2) If the employee was not eligible for membership of the scheme immediately before the transfer day, the employee is taken to be not eligible for membership of the scheme on or after the transfer day.
- '(3) In this section—
