1 Short title

This regulation may be cited as the *Nature Conservation* (*Protected Areas*) *Amendment Regulation* (*No.* 8) 2011.

2 Commencement

This regulation commences on 18 December 2011.

This regulation amends the *Nature Conservation (Protected Areas) Regulation 1994*.
