# Transitional provision for Water and Other Legislation Amendment Regulation (No. 1) 2012

### '131 Carrying out particular activities under environmental authority

- This section applies to an environmental authority that permits the holder of the authority to carry out, under the document called 'Guideline—Activities in a watercourse, lake or spring associated with mining operations', any of the following activities—
  - (a) destroying vegetation in a watercourse, lake or spring;
  - (b) excavating in a watercourse, lake or spring;
  - (c) placing fill in a watercourse, lake or spring.
- '(2) From the commencement of this section, a reference in the environmental authority to the document mentioned in subsection (1) is taken to be a reference to

'Guideline-Activities in a watercourse, lake or spring associated with a resource activity or mining operations'.

'(3) In this section—

*environmental authority* means the following environmental authorities under the *Environmental Protection Act 1994*—

- (a) an environmental authority (mining activities);
- (b) an environmental authority (chapter 5A activities).'.
