## **Part 1 Preliminary**

### **1 Short title**

This regulation may be cited as the *Liquor and Other Legislation Amendment Regulation (No. 1) 2013*.

## **Part 2 Amendment of Liquor Regulation 2002**

### **2 Regulation amended**

This part amends the *Liquor Regulation 2002*.

### **3 Amendment of s 7 (Circumstances in which commissioner may approve premises as detached bottle shop)**

(1) Section 7(1)(d)(ii)—

*omit.*

(2) Section 7(1)(d)(iii) to (vi)—

*renumber* as section 7(1)(d)(ii) to (v).

### **4 Amendment of s 12 (Application for relocation of detached bottle shop—Act, s 154A)**

(1) Section 12(a)—

*omit.*

(2) Section 12(b) and (c)—

*renumber* as section 12(a) and (b).

(2) Section 11(e) and (f)—

*omit, insert—*

- (e) for the holder of a licence under the *Liquor Act 1992* only—
  - (i) if the licence is a commercial hotel licence or community club licence under that Act—
    - (A) part of the premises of which the licensed premises to which the licence relates forms part; or
    - (B) a place mentioned in paragraph (b)(i); or
  - (ii) otherwise—
    - (A) part of the premises, of which the licensed premises to which the licence relates forms part, approved by the chief executive; or
    - (B) a place mentioned in paragraph (b)(i);
- (f) for the holder of a licence under the *Liquor Act 1992* who also holds a gaming machine licence under the *Gaming Machine Act 1991*—
  - (i) part of the premises of which the licensed premises to which the licence under the *Liquor Act 1992* relates forms part; or
  - (ii) a place mentioned in paragraph (b)(i);
