## **Part 1 Preliminary**

### **1 Short title**

This regulation may be cited as the *Industrial Relations and Another Regulation Amendment Regulation (No. 1) 2014*.

### **2 Commencement**

- (1) Part 2, other than section 4, commences on 31 August 2014.
- (2) Section 4 commences on 30 September 2014.
- (3) Part 3 is taken to have commenced on 1 July 2014.
