1 Short title

This regulation may be cited as the *Health (Drugs and Poisons) Amendment Regulation (No. 1) 2015*.

2 Regulation amended

This regulation amends the *Health (Drugs and Poisons) Regulation 1996*.

270B Approval for cannabis

The chief executive may grant an approval to a person to administer, dispense, manufacture, obtain, possess, prescribe, supply or use an S9 poison if—

- (a) the S9 poison is cannabis; and
- (b) the approval is for or connected with—
 - (i) an approved clinical trial; or
 - (ii) an approval, for the supply of cannabis for use in the treatment of a person, given under the *Therapeutic Goods Act 1989* (Cwlth), section 19(1).

9 Amendment of s 292 (Advertising of poisons)

Section 292(5)—

omit, insert—

- (5) Subsection (4) does not apply to—
 - (a) a person who refers to cannabis in an advertisement in connection with an approved clinical trial; or
 - (b) a person who refers to *Cannabis sativa* in an advertisement in connection with an activity

Appendix 9—

approved clinical trial means a clinical trial approved by—

- (a) the Therapeutic Goods Administration; or
- (b) a human research ethics committee registered by the Australian Health Ethics Committee established under the *National Health and Medical Research Council Act 1992* (Cwlth).
