1 Short title

This regulation may be cited as the Major Events (Motor Racing Events) (Townsville 400) Amendment Regulation 2017.

2 Regulation amended

This regulation amends the *Major Events (Motor Racing Events) Regulation 2015*.

3 Amendment of s 3 (Townsville 400 is a major event)

Section 3, '2016'—

omit, insert—

4 Amendment of s 6 (Major event period for Townsville 400)

Section 6, from '7 July 2016' to '11 July 2016'—

omit, insert—

6 July 2017 and midday on Monday 10 July 2017

5 Amendment of s 7 (Carrying out temporary works for Townsville 400)

Section 7(a) and (b)—
omit, insert—

- (a) between 29 May 2017 and midday on 6 July 2017;
- (b) between midday on 10 July 2017 and 29 July 2017.

6 Amendment of s 8 (Declaration of official title for Townsville 400)

Section 8, '2016 Castrol EDGE'—

omit.

7 Amendment of s 20 (Assessing building work for special fire service)

- (1) Section 20, heading, 'for special fire service'— *omit.*
- (2) Section 20(2)(a) and (b)—
 omit, insert—
 - (a) consult the Queensland Fire and Emergency Service about a special fire service or any work involving a fire-related alternative solution for the building work; and
 - (b) if the building work is for a building or structure that is proposed to have a special fire service or involves a fire-related alternative solution—obtain and consider a report from the Queensland Fire and Emergency Service on the suitability of the proposed special fire service or fire-related alternative solution.
- (3) Section 20(3)—

insert—

building work see the *Building Act 1975*, section 5.

fire-related alternative solution means an alternative solution as defined under the Building Act 1975, schedule 2 for performance requirements relating to fire safety.

performance requirements see the *Building Act* 1975, schedule 2.
