## **1 Short title**

This regulation may be cited as the *Aboriginal and Torres Strait Islander Communities (Justice, Land and Other Matters) (Community Justice Group Membership) Amendment Regulation 2018*.

## **2 Commencement**

This regulation commences on the commencement of the *Court and Civil Legislation Amendment Act 2017*, part 2.

## **3 Regulation amended**
