#### 1 Short title

This plan may be cited as the *Water Plan (Burdekin Basin)* (Applications for Water Licences) Amendment Plan 2020.

### 2 Plan amended

This plan amends the Water Plan (Burdekin Basin) 2007.

### 3 Declaration—Act, s 1259

## 4 Amendment of s 26A (Particular applications for water licences that must not be accepted)

Section 26A(1)—

omit, insert—

- (1) This section does not apply to an application for a water licence if—
  - (a) section 26 applies to the application; or
  - (b) the application is for a licence to interfere with the flow of surface water to artificially change or improve the course of a watercourse, lake or spring; or
  - (c) the application—
    - (i) is made as part of the process mentioned in section 33A(2) for releasing unallocated water; and
    - (ii) is for a licence to take—
      - (A) surface water held as a general reserve in subcatchment area E, F or G; or
      - (B) surface water held as a strategic reserve for a State purpose in subcatchment area E, F or G.
