Part 1 Preliminary

1 Short title

This declaration may be cited as the *Fisheries Legislation Amendment Declaration 2021*.

2 Commencement

- (1) Part 2, division 2 commences on 1 July 2021.
- (2) Part 2, division 3 and part 3, division 2 commence on 1 September 2021 immediately after the commencement of the *Fisheries Legislation Amendment Regulation 2020*, chapter 4.
- (3) Part 2, division 4 commences on 1 January 2022.
- (4) Part 3, division 3 commences on 1 July 2022.






