1 Short title

This regulation may be cited as the *Acts Interpretation (Fee Unit) Regulation 2022*.

2 Value of fee unit generally—Act, s 48B

From 1 July 2022 the value of a fee unit for an Act, other than an Act or a part of an Act mentioned in schedule 1, is \$1.025.

3 Value of fee unit for particular Acts—Act, s 48B

- (1) The value of a fee unit for an Act or a part of an Act mentioned in schedule 1, part 1, is—
 - (a) from 1 July to 31 August 2022—\$1.00; and
 - (b) from 1 September 2022—\$1.025.
- (2) The value of a fee unit for an Act or a part of an Act mentioned in schedule 1, part 2, is—
 - (a) from 1 July to 30 September 2022—\$1.00; and
 - (b) from 1 October 2022—\$1.025.
- (3) The value of a fee unit for an Act or a part of an Act mentioned in schedule 1, part 3, is—
 - (a) from 1 July to 31 December 2022—\$1.00; and
 - (b) from 1 January 2023—\$1.025.
- (4) The value of a fee unit for an Act or a part of an Act mentioned in schedule 1, part 4, is—
 - (a) from 1 July 2022 to 30 April 2023—\$1.00; and
 - (b) from 1 May 2023—\$1.025.
