#### 1 Short title

This regulation may be cited as the Major Events (Motor Racing Events) (Gold Coast 500) Amendment Regulation 2022.

### 2 Regulation amended

This regulation amends the *Major Events (Motor Racing Events) Regulation 2015*.

### 3 Amendment of s 2 (Definitions)

- (1) Section 2, definition *Gold Coast 600—omit.*
- (2) Section 2—

*Gold Coast 500* means the major event prescribed under section 9.

(3) Section 2, definition *motor racing event*, paragraph (a), '600'—

### Part 3 Gold Coast 500

### 9 Gold Coast 500 is a major event—Act, s 12

For section 12(1) of the Act, the V8 Supercars motor racing event known as the Gold Coast 500 to be held in 2022 is prescribed as a major event.

### 10 Major event organiser for Gold Coast 500—Act, s 12

For section 12(2)(a) of the Act, V8 Supercars Australia Pty Ltd ACN 077 053 484 is prescribed as the major event organiser for the Gold Coast 500.

### 11 Major event area for Gold Coast 500—Act, s 12

For section 12(2)(b) of the Act, the major event area prescribed for the Gold Coast 500 is the area consisting of the following areas, shown on the map in schedule 2 as the major event area—

- (a) the areas surrounding Macintosh Island Park in Surfers Paradise;
- (b) the areas in the Southport Broadwater Parklands;
- (c) 3332 Surfers Paradise Boulevard, Surfers Paradise.

#### 12 Major event period for Gold Coast 500—Act, s 12

For section 12(2)(c) of the Act, the major event period for the Gold Coast 500 is the period from midday on 27 October 2022 to midday on 31 October 2022.

### 13 Carrying out temporary works for Gold Coast 500—Act, s 16

For section 16(2) of the Act, the following periods are prescribed—

- (a) from the beginning of the day on 19 September 2022 to midday on 27 October 2022;
- (b) from midday on 31 October 2022 to midnight on 19 November 2022.

### 14 Declaration of official title for Gold Coast 500—Act, s 51

For section 51(1)(b) of the Act, the title '2022 Boost Mobile Gold Coast 500' is declared an official title for the Gold Coast 500.


