# **Appropriation (Parliament) Bill 2022**

## **Explanatory Notes**

#### Short title

The short title of the Bill is the Appropriation (Parliament) Bill 2022.

#### Policy objectives and the reasons for them

Section 27(b) of the *Financial Accountability Act 2009* provides that, for each financial year, the Treasurer must present to the Legislative Assembly a Bill for a parliamentary Annual Appropriation Act.

## **Achievement of policy objectives**

The Bill provides for:

- Appropriation for 2022-23 to fund the cost of providing the services, equity adjustment and administered items of the Legislative Assembly and parliamentary service in that year; and
- Supply for 2023-24 to allow the normal operations of the Legislative Assembly and parliamentary service to continue until the 2023-24 Appropriation (Parliament) Bill receives assent.

There is no supplementary unforeseen expenditure included in this Bill. The supplementary appropriation for 2020-21 unforeseen expenditure was included in the *Appropriation (Parliament) (No.2) Act 2022*. Consistent with this approach, any supplementary appropriation for 2021-22, identified following the completion of annual financial statements, will be included in a separate appropriation Bill.

## Alternative ways of achieving policy objectives

The policy objectives can only be achieved by legislation.

## **Estimated cost for government implementation**

The Bill will provide appropriation for the Legislatively Assembly and parliamentary service for the 2022-23 financial year and interim supply for 2023-24 until 2023-24 Appropriation (Parliament) Bill receives assent.

The administrative cost to government to implement the Bill will be met from existing Queensland Parliamentary Service budget allocation as it is considered a fundamental role of the Queensland Parliamentary Service.

#### Consistency with fundamental legislative principles

The Bill is consistent with fundamental legislative principles.

#### Consultation

Consultation has been undertaken with the Speaker in determining the appropriation requirements of the Legislative Assembly and the parliamentary service.

### **Consistency with legislation of other jurisdictions**

The Bill is specific to the State of Queensland and is not complementary to legislation of the Commonwealth or another state.

# **Notes on provisions**

Clause 1 provides for the short title of the Act.

Clause 2 provides that the amount of \$146,721,000 is appropriated for the 2022-23 financial year for the Legislative Assembly and parliamentary service for application to its departmental services, administered items and equity adjustment as set out in Schedule 1.

Clause 2(3) provides that the amount of \$146,721,000 includes amounts already authorised by Appropriation (Parliament) Act 2021, to be paid for the financial year starting 1 July 2022.

Clause 3 provides that the amount of \$73,361,000 is appropriated for the 2023-24 financial year for the Legislative Assembly and parliamentary service for application to its departmental services, administered items and equity adjustment until the Appropriation (Parliament) Bill for 2023-24 receives assent.

Clause 4 repeals the Appropriation (Parliament) Act 2020 (Act No. 36 of 2020) and Appropriation (Parliament) (2020-2021) Act 2021 (Act No. 1 of 2021).

Schedule 1 details the total amount appropriated for the Legislative Assembly and parliamentary service and the amount for application to its departmental services, administered items and equity adjustment in 2022-23.
