Establishment of council 6
5. The Queensland School Curriculum Council (P-10) is established.

Council's functions 8
6.(1) The council's main functions are as follows- 9
(a) to develop P-10 syllabuses; 510
(b) to develop initial in-service materials and source books for years 11 1 to 10 ; 12
(c) to advise the Minister on the development of P-10 syllabuses; 13

(i) to develop and, from time to time, revise a strategic plan for 15

(c) 1 person nominated by the Queensland Catholic Education ..... 25
Commission; ..... 26
(d) 1 person nominated by the Association of Independent Schools ..... 27
