The Parliament of Queensland enacts—

(3) The council's chief executive officer must keep copies of ear planning deed available for inspection at the council's public office at times when the office is open for business.

10. This Act is a law to which the <i>Acts Interpretation Act 1954</i> , section 20A ⁵ applies.	22 23
Regulation-making power	24
11. The Governor in Council may make regulations under this Act.	25
