'Executive officer

'40. The person holding office as the executive officer of the Qsuper 20 board immediately before the commencement continues to hold office 21 under section 6D until the person's appointment is ended. 22

'Annual report

'41.(1) The next annual report made after the commencement must 24 include a report on the administration of each of the discontinued schemes 25 during the financial year ending 30 June 1997. 26
