Maximum penalty—40 penalty units.		
'(3) On Saturday 26 December 1998, the occupier of an excluded shop must ensure the shop is closed at all times other than the times at which it may be open under the trading hours order on a public holiday.		
Maximum penalty—40 penalty units.	8	
'(4) However on Saturday 26 December 1998, the occupier of an excluded shop in the "area of the city heart" of the inner city of Brisbane, as defined in the trading hours order, must ensure the shop is closed at all times other than times at which it may be open under the trading hours order on Boxing Day.	9 10 11 12 13
