Section 119 (Regulator's role in disputes between electricity entity and customers or occupiers) 1

'Remuneration 1 '64U.(1) An energy arbitrator is to be paid the remuneration and 2 allowances approved by the Governor in Council. 3 (2) The remuneration and allowances must be paid out of levies paid to 4 the chief executive by electricity entities under section 64AA. 5 'Resignation 6 **'64V.(1)** An energy arbitrator may resign by signed notice of resignation 7 given to the Minister. 8 (2) The Minister must give notice of the resignation by gazette notice. 9 'Termination of appointment 10 '64W.(1) The Minister, by written notice given to an energy arbitrator, 11 may terminate the person's appointment as an energy arbitrator if the 12 Minister reasonably believes the person is not satisfactorily performing the 13 functions of an energy arbitrator. 14 (2) The notice must contain the Minister's reasons for terminating the 15 appointment. 16 (3) The Minister must give notice of the termination by gazette notice. 17 'Division 2—Functions and powers 18 'Functions 19 '64X.
