**The Parliament of Queensland enacts—** 1

**PART 1—PRELIMINARY** 2

**Clause 1 Short title** 3

This Act may be cited as the *Education (Miscellaneous Amendments) Act 2002*. 4

Sections 6 and 28 to 33 are taken to have commenced on 1 January 2002. 7

‘(4) A person is to be elected to the office by a ballot under section 15(3). 9

- (a) if the elected member was a student—the council may authorise the council of the student association to appoint a student to the office at a meeting of the council of the student association; and 11

- (b) if the elected member was a member of the convocation—the council may authorise the convocation to appoint a member of the convocation to the office at a meeting of the convocation at which a quorum is present. 14
