State athlete, ASADA seeks the consent of the athlete’s 6
parent or guardian to the sample being supplied or 7
taken.’. 8

A person is *receiving State support* if the person, for taking 6
part or training to take part in sporting activities— 7

(a) receives funding from the State; or 8

(b) uses facilities provided by the State, or operated or 9
maintained with funding from the State; or 10

(c) is a member of, or is associated with, a State sporting 11
organisation that— 12

(i) receives funding from the State; or 13

(ii) uses facilities provided by the State, or operated or 14
maintained with funding from the State; or 15

(iii) receives advice or other services from the State. 16

State sporting organisation means a sporting organisation 17
recognised by the agency responsible for the administration of 18
sport in the State as the sporting organisation for a sport in the 19
State.’. 20
