- Commonwealth Act*** means the *Australian Sports Anti-Doping Authority Act 2006* (Cwlth). 1

- NAD scheme*** means the NAD scheme under the Commonwealth Act. 3

- receiving State support***— 5
- A person is *receiving State support* if the person, for taking part or training to take part in sporting activities— 6

- (a) receives funding from the State; or 8
- (b) uses facilities provided by the State, or operated or maintained with funding from the State; or 9

- (c) is a member of, or is associated with, a State sporting organisation that— 11  
12
- (i) receives funding from the State; or 13
- (ii) uses facilities provided by the State, or operated or maintained with funding from the State; or 14

- (iii) receives advice or other services from the State. 16
- State sporting organisation*** means a sporting organisation recognised by the agency responsible for the administration of sport in the State as the sporting organisation for a sport in the State.’. 17
