**An Act to provide for protection of a person against violence committed or threatened by someone else if a relevant relationship exists between the persons, and to make amendments of the Criminal Code, the *Evidence Act 1977*, the *Police Powers and Responsibilities Act 2000* and the *Police Powers and Responsibilities Regulation 2000* for particular purposes, and to make minor or consequential amendments of this Act and other legislation as stated in a schedule**

The man orally authorises his grandfather to apply for a protection order against the uncle. The court may believe the grandfather is authorised to appear on behalf of the man after hearing evidence about the authorisation.

- (3) A person who may make an application for a protection order under subsection (1) may make other applications or bring other proceedings under this Act in relation to a domestic violence order made because of the application for the protection order.
