231 Current proceedings

- (1) This section applies to a proceeding that, 16 immediately before the commencement, had not 17 ended and to which QTAMA was a party. 18
- (2) On the commencement, the State becomes a 19 party to the proceeding in place of QTAMA. 20

232 Proceedings not yet started

- This section applies if, immediately before the commencement, a proceeding could have been started by or against QTAMA within a particular period.

- (2) The proceeding may be started by or against the 26 State within the period. 27

233 Registering authority to note transfer or other 28 dealing 29

(1) A registering authority must, on written 30 application by the chief executive and without 31
