(1) The Treasurer is authorised to pay \$5,740,982,000 from the 13
consolidated fund for departments as stated in schedule 1 for 14
the financial year starting 1 July 2024. 15

for the department for application to its departmental services, 18
equity adjustment and administered items as stated in 19
schedule 1. 20
