# Aboriginal and Torres Strait Islander Land Holding Bill 2012

# Explanatory Notes for amendments to be moved during consideration in detail by the Honourable Andrew Cripps MP

#### Title of Bill

Aboriginal and Torres Strait Islander Land Holding Bill 2012

#### Objectives of the amendments

The amendments to be moved during consideration are to implement a recommendation of the Agriculture, Resources and Environment Committee in tabled Report No. 10 in relation to the Aboriginal and Torres Strait Islander Land Holding Bill 2012. The recommendation being implemented is that the Bill be amended to change the name of 'community reference panel' for a trust area to be the 'Land Holding Act stakeholder reference panel' to more accurately capture the composition of the panel and remove any potential misconceptions about the representation on the panel or the functions of the panel.

# Achievement of the objectives

The objectives of the amendments are achieved by amendments to the Bill.

# Alternative ways of achieving policy objectives

Legislative amendment is the only means of achieving the policy objectives.

#### **Amendment 14**

#### **Amendment 15**
