#### 1 Short title

This regulation may be cited as the *Royal National* Agricultural and Industrial Association of Queensland Regulation 2010.

#### 2 Prescribed land—Act, s 17D

For the Act, section 17D, the following land is prescribed—

- (a) lot 701 on SP219236 situated in the County of Stanley, containing an area of 2.878ha;
- (b) lot 702 on SP219237 situated in the County of Stanley, containing an area of 0.7513ha;
- (c) lot 703 on SP219238 situated in the County of Stanley, containing an area of 6.978ha;
- (d) lot 704 on SP219239 situated in the County of Stanley, containing an area of 4.065ha.
